Ms. Housteau called the meeting to order at 9:09 a.m. A quorum was present.

Contested Case Hearing

The Honorable Stephen Darnell, Administrative Judge, presided over the hearing for **Addie Belle Guinn, LCSW**. Ms. Appelt, Assistant General Counsel, represented the State.

Mr. Pharris made a motion, seconded by Ms. Williams, to accept the findings of facts as presented and to place Ms. Guinn on two (2) years of probation as of the date of the order. For her continuing education requirements in 2011 and 2012, Ms. Guinn must complete no less than three (3) hours of the required fifteen (15) hours per year in social worker ethics; and no less than three (3) hours of the required fifteen (15) hours per year in Center for Medicare/Medicaid Services (CMS). In addition to the yearly continuing education hours required to maintain a clinical social worker license for the years 2011 and 2012, respondent must obtain no less than six (6) additional hours in social worker license for the years 2011 and 2012. Respondent must obtain no less than six (6) additional in social worker supervision over the two (2) year probationary period; and no less than three (3) additional hours per year in social worker ethics,

for a total of six (6) additional hours in social worker ethics over the two (2) year probationary period. The motion carried.

Ms. Mazzaferro made a motion, seconded by Ms. DeMott, to require Ms. Guinn to pay a \$1,000 civil penalty for violation of the social worker practice. The motion carried.

Ms. Axley made a motion, seconded by Ms. Horton, to require Ms. Guinn to pay costs not exceeding three thousand dollars (\$3,000). The motion carried.

Ms. Pharris made a motion, seconded by Ms. Mazzaferro, to accept the conclusions of law. The motion carried.

Ms. DeMott made a motion, seconded by Ms. Mazzaferro, to adopt as a policy statement that this action is taken to protect the public's health, safety and welfare of the citizens of the state of Tennessee. The motion carried.

Applicant Interviews

Vander Dale presented an appeal to the Board for denying his application for licensure as a LMSW at the August 5, 2010 meeting. Upon discussion and review of the documentation Mr. Dale presented to the Board, Ms. DeMott made a motion, seconded by Ms. Williams, to approve Mr. Dale for licensure as an LMSW. The motion carried.

Qiana Jones attended the meeting, at the Board's request, to discuss her LMSW application. Upon discussion of Ms. Jones employment, Ms. Mazzaferro made a motion, seconded by Ms. Horton, to approve Ms. Jones for licensure as an LMSW. The motion carried.

Minutes

Ms. Mazzaferro made a motion, seconded by Ms. Alexander, to approve the November 18-19, 2010 minutes as amended. The motion carried.

OGC Report

There are five (5) open disciplinary files in the Office of General Counsel. OGC has drafted a revised continuing education policy incorporating the discussion from the last meeting with regard to waiving the continuing education hours for newly licensed members of the profession.

Ms. Appelt discussed HB76 which prevents the Board's funds from being transferred to any other state department or agency of state government. Ms. Williams made a motion, seconded by Ms. Mazzaferro, to support HB76. The motion carried.

Agreed Citations

Ms. Horton made a motion, seconded by Ms. Alexander, to approve the following Agreed Citations:

Rosemary Whitson, LMSW, continuing education violation.

Felice Leslie Apolinsky, LCSW, working on a lapsed license.

The motion carried.

Investigative Report

There are six (6) open cases for LCSW's and eight (8) open cases for CMSW's.

Disciplinary Report

There are four (4) LCSW's, two (2) CMSW's, and one (1) non-licensed person being monitored.

Administrative Report

There are 412 active licensed baccalaureate social workers, 2387 active licensed master social workers, 144 active licensed advanced practice social workers and 2127 active licensed clinical social workers.

Between January 2010 and June 2010 thirteen (13) LMSW's were audited, five (5) were compliant; twenty (20) LCSW's were audited, eighteen (18) were compliant.

Financial Report

For FY2010 the Board has direct expenditures of \$118,178.0, indirect expenditures of \$94,011.90, revenue of \$326,759.36 and a current year net of \$114,569.44.

The Board approved a request from **Jo Elks, LMSW**, requesting a waiver of the one (1) hour of continuing education for 2009. Ms. DeMott recused herself. Mr. Pharris made a motion, seconded by Ms. Horton, to grant the request. The motion carried.

Review Policy on Continuing Education

The Board reviewed the policy statement pertaining to licensees who fail to obtain continuing education. Ms. Appelt said it was suggested at the last meeting that the continuing education hours are waived for the first year of licensure. Mr. Pharris stated LBSW's and LMSW's receive continuing education credit for the first licensure year for obtaining their degree. Upon discussion, Ms. DeMott made a motion, seconded by Ms. Axley, to amend the policy statement to exempt the continuing education requirements for new applicants applying for the LBSW and LMSW levels of licensure for the calendar year in which they are first licensed. The motion carried.
