

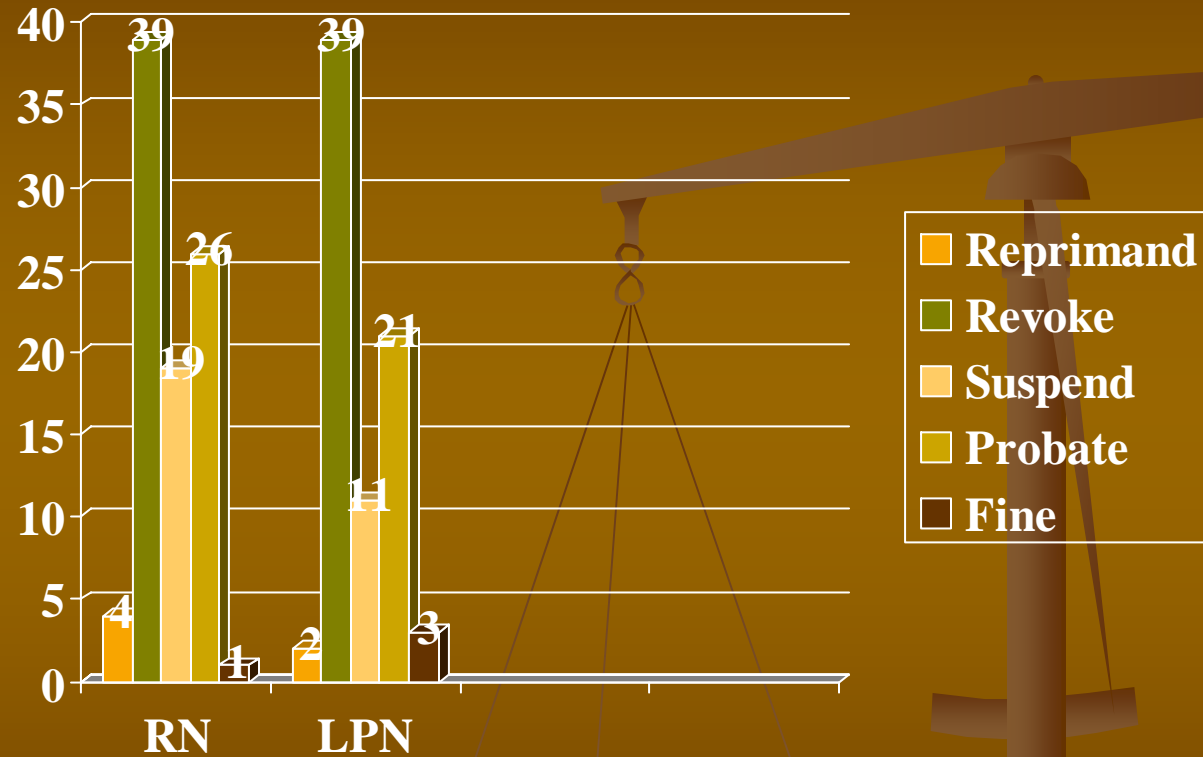
Screening Panel Formal Actions



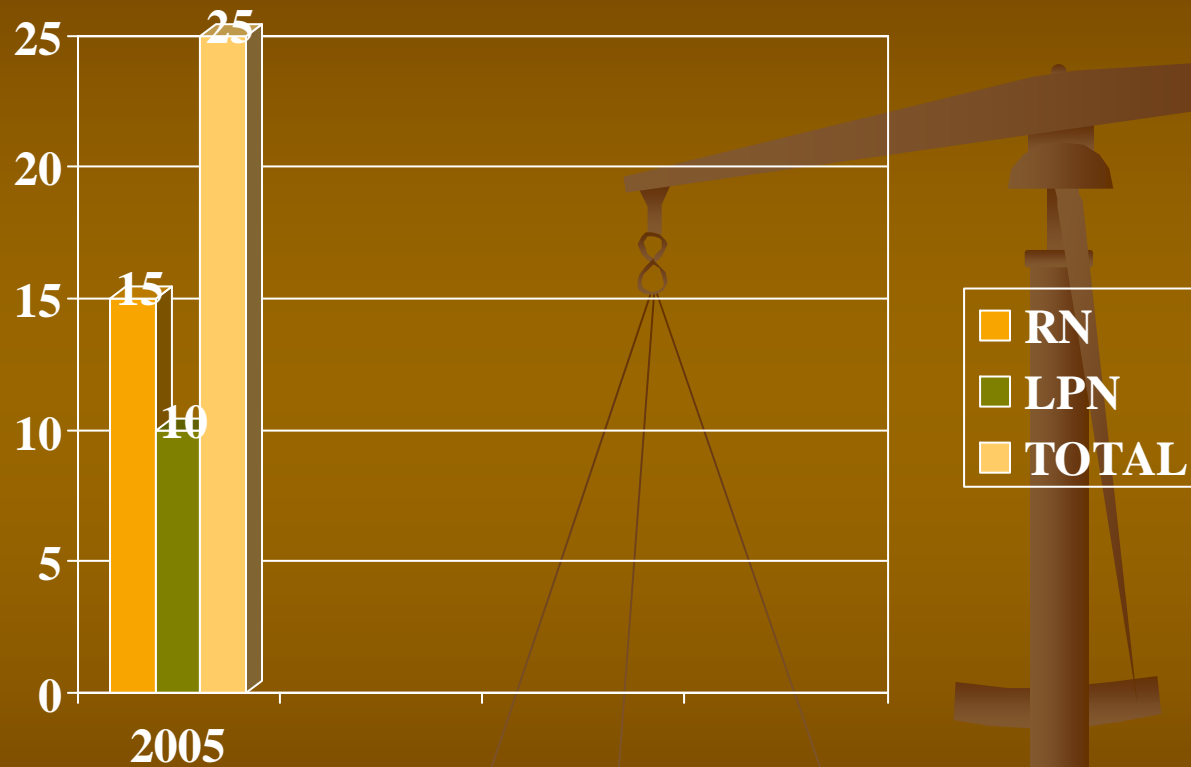
Disciplinary Action 2001-2005

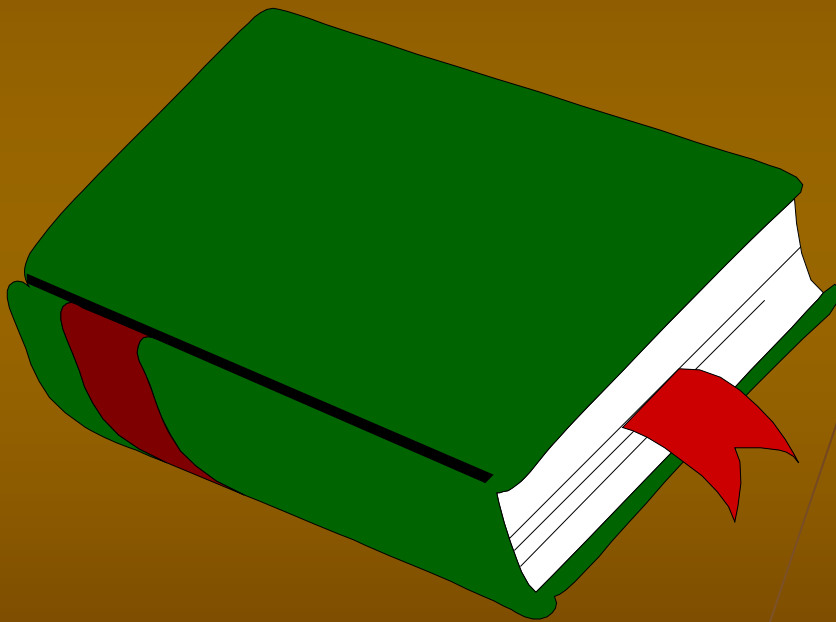

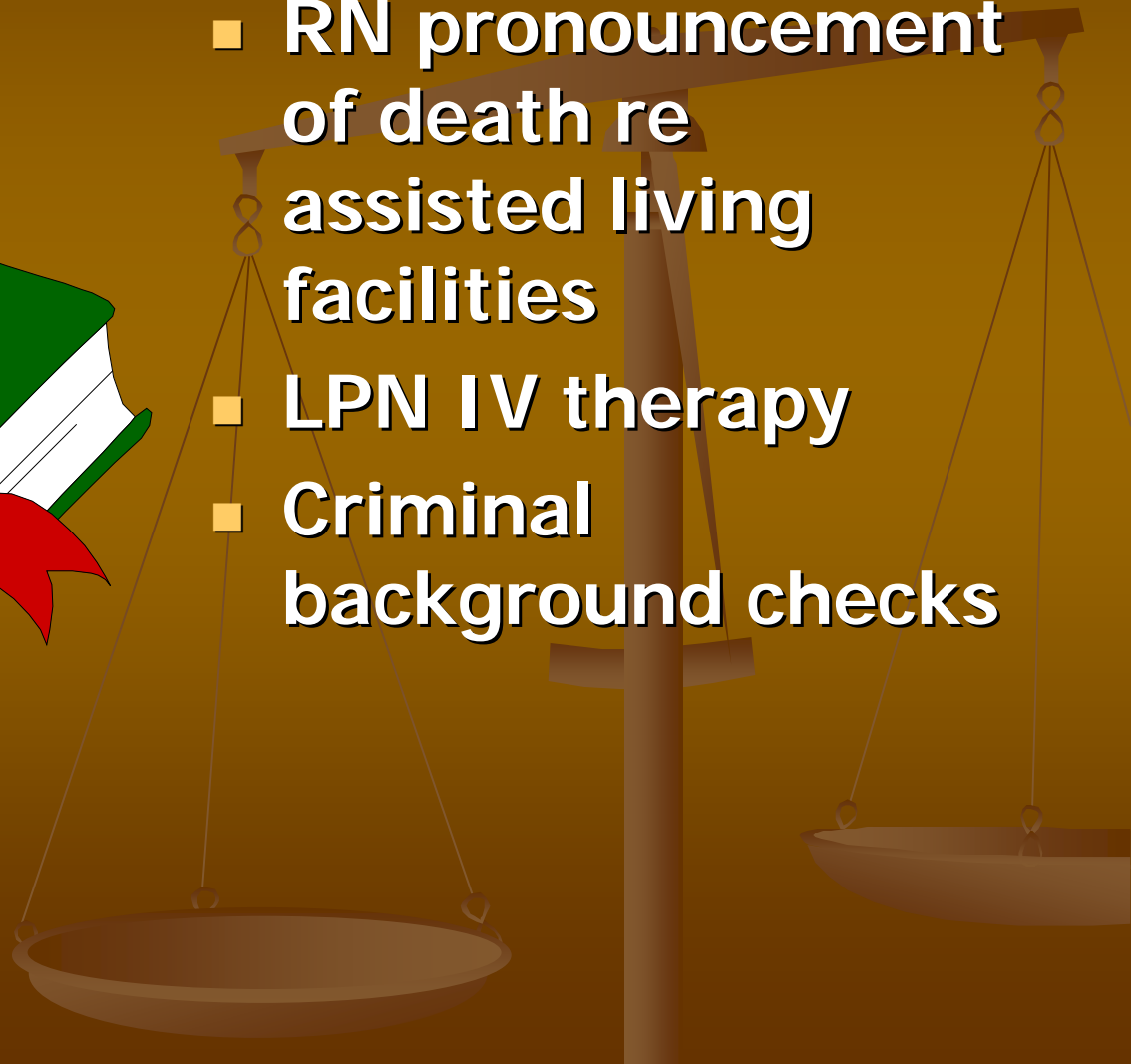
